
# Byron Business Review

A review of Byron's business and professional men at the time of the formal opening of the new building of the First National Bank on June 4, 1952.



New home of The First National Bank of Byron


Probably the first thing a stranger looks for in a town is the bank. It is his assurance that there is a thriving business group, able to maintain a full agenda of transactions on a commercial basis. The presence of a bank in a community immediately sets the whole citizenry upon a business par with anyone else in the country.

That very need for financial security and backing prompted the formation of the first bank in Byron by Junius Rogers in 1873, just 28 years after the founding of Byron. Mr. A. B. Knowlton was cashier and partner in this bank, which was located on Second and Union Streets. Mr. Rogers was succeeded by Mr. Knowlton and he was followed by Mr. W. D. Brown of Geneva, who in turn was followed by R. D. Hollenbeck.

Meanwhile, J. C. Woodburn, in 1882, had organized a bank, a private institution which was continued many years under private management. In 1885 D. H. Campbell assumed the management and in 1892 S. B. Stuart, in partnership with other men, purchased the bank and it became known as the Byron Bank.

In 1921 it became the Byron State Bank when it took over the Farmers and Merchants Bank.

Wm. C. Bunn had withdrawn from the Byron Bank in 1891 and had established the Farmers and Merchants Bank, which in later years built the bank building which The First National Bank has just left. They continued in the new building until taken over by The Byron Bank and became the Byron State Bank until 1931.




Spacious interior of the new bank building.

The year 1931 was a time of distress in Byron for the bank closed and business was slowed perceptibly in the community. The need for a new bank became acute and finally on June 30, 1932 a charter was filed under the name of Rock River Community Bank with the organizers listed as Albert Johnson, Leo Piper, E. F. Reber, F. A. Nott, E. G. Stukenberg and D. L. Sherman. The roster of stockholders was impressive, indicating that the community spirit was at its highest point and was behind the venture whole-heartedly. Three hundred and four of the 915 citizens owned stock in this new bank.

A large celebration was organized to make festive the opening of the bank on July 7. Mayor Spoor opened the program and Mr. James W. Rogers, the new President, was introduced, as well as F. A. Nott, Vice-President, and other directors. Dr. Stewart Thomson acted as master of ceremonies and it was at this occasion that the support of Ruth Hanna Simms was announced. She pledged 10 per cent of the funds necessary for reorganization and her financial secretary was made president of the new institution which was capitalized at \$50,000. Total resources of the bank were then \$276,261.34. It was a small bank, but was one of the strongest in the Midwest in liquidity. The fact that the bank opened during an economic crisis and remained at the service of the community demonstrates the soundness of the organization.

In 1939 F. A. Nott was made President followed by O. F. Bakener in 1941, Leo Piper in 1943 and E. J. Auker in January of 1947.





Mr. E. J. Auker came to Byron in 1941 and when the opportunity presented itself in 1946, bought, with his sons, M. E. and B. E. Auker, the controlling interest in the bank. In July of 1947 the bank was nationalized and became known as The First National Bank of Byron. The officers of the bank are: E. J. Auker, President; M. E. Auker, Vice-President; Ken Swanson, Cashier; Nina Thompson, assistant cashier; directors are E. F. Reber, B. E. Auker, M. E. Auker, Ken Swanson and E. J. Auker.

With resources nearly ten times that (as of 1932) of the Rock River Community Bank (\$2,434,313.40) and business activities increasing proportionately the Board of Directors have erected a new building on the corner of Second and Walnut Streets, with Don B. Johnson, contractor.

Constructed of tan brick and crab orchard stone, the building provides the latest in banking facilities — namely the Drive-In Banking Window, a night depository as well as 100 added safety deposit boxes. The lobby is harmoniously designed to satisfy the most discriminating.

The National Room on the lower level of the bank will seat 75 people. Kitchen facilities will be available. This room is a reflection of the strong community spirit of the entire First National Bank organization.



E. J. Auker

E. J. Auker, president of The First National Bank, was born Aug. 11, 1890 on a ranch in Western Nebraska. In 1899 his father traded the ranch for a farm in Eastern Nebraska. Mr. Auker farmed with his father until he was 19 years old. Then, he bought half interest in a blacksmith shop. He sold this interest in a short time.

Married in 1910, Mr. Auker began farming, and buying and selling cattle. During the drought and depression, he worked for some time for the RFC in making and inspecting loans. In 1933 he began devoting all of his time to the cattle business.

During three winters at El Paso, Texas, he brought several thousand cattle out of Old Mexico. He also bought cattle all over the range country and shipped them East to be fattened for market.

Mr. Auker purchased a farm near Byron in 1940 and took his two sons into partnership. During 1940 he stayed in the West until he had sold the cattle for which he had contracted. In 1941 the Aukers opened the livestock sales barn in Byron which they still operate.

In 1946 they bought controlling interest in the Rock River Community Bank.



Ken Swanson

Ken Swanson, cashier of the First National Bank, is a graduate of Rockford Public Schools and of Browns Business College.

For five years he was employed at the Rockford National Bank. At the end of that time he was transferred to the Rockford Trust Co.


In 1935 he moved to Byron when he became Assistant Cashier of the Rock River Community Bank. In 1941 he became Cashier and Director.

Mr. Swanson is a City Alderman, School Treasurer and Vice President of the Byron Theatre.




This high school building was built in 1939





#### **Bakener Funeral Home**

The Bakener Funeral Home, founded July 1, 1933 by Orville F. Bakener, is dedicated to the memory of those who in eternal sleep repose therein, and is for the use and comfort of relatives and friends.

This is one of the oldest houses in Byron and it is recorded that as late as 1862 many slaves were hidden and fed in this building while enroute from the Mason-Dixon line to points on the Canadian border.

On October 10, 1862 a dinner, followed by a ball, was held in this property for members of the 92nd Illinois Infantry who were leaving the next day from Rockford for Cincinnati from whence they went into service near Mt. Sterling and Danville, Kentucky.

Service night or day, Sundays and holidays is one of the reasons for the success of Mr. Barnhart's business.









## Byron General Machine Repair


On Sept. 1, 1946 Mr. Oscar H. Johnson began operating the Byron General Machine Repair shop.

Shafts and most any new part made that is beyond repairing.



"Quality With Service" is the slogan for the Byron Hatchery Co. The old Gill's Hall was remodeled into an up-to-date hatchery for the operation of this business.




# Byron Implement Co.



Two complete shows are presented each night. For an evening of enjoyable entertainment you can count on the Byron Theatre.


# **Byron Tribune**






## **Certified Super Mart**




Robert Cox, Ralph Dyer and Gene Moring standing by one of their milk delivery trucks.


Robert L. Cox has been distributing Dean's milk wholesale throughout most of Ogle county since 1945.

# The United Church of Byron

The United Church of Byron is the union of religious effort begun in the spring of 1837. The Methodists and Congregationalists worked parallel until 1930 when the question of the merger was proposed. With both churches' officers voting for the union, the properties were incorporated under one board of trustees; the membership was placed in one book: the membership of the United Church. During the last six years the property has been improved about \$1,000 each year, not counting a \$5,000 pipe organ in March, 1948. Six ministers have served the United Church: L. M. Isaacs, W. J. Hopkins, Ralph Vieth, Fred N. Anderson, J. K. Arnot and James H. Hagerty.



## St. Mary's Church, Byron

St. Mary's Catholic Church was organized by Father John McCann in April, 1895. A few months later the church building was started, financed in part by a successful fourteen-night "Catholic Fair" at which \$1,500 was raised — a considerable sum in those days! Mary Nally (Carver) was voted the most popular girl at the fair, and her daughter, Mrs. Robert Cox, still has the silver teapot which was presented to her mother on that occasion. Almost all the work on construction was donated, and the church was dedicated on June 3, 1896 by His Grace, Archbishop Feehan. Prior to that time, Mass was said either at Gill's Hall, or the Masonic Hall, which was directly across the street from where the church now stands.

A few of the families belonging to early congregations were: Riley, Hogans, Barry, Nally, Kennedy, Mayewski, Higgins, Leary, Hickey, Rush, Gorman, O'Mally, Kiley, Connor, Whalen, Quinlan and Diggens.

St. Mary's has been served by priests from Oregon; among them are the present pastor, Rev. Arthur M. Kreckel, his predecessor, Father Thomas Meehan, and before that, Father J. J. Hackett, who was "the priest" in the Centennial pageant held here in 1935.




#### Dr. Robert F. Dearborn's Office

Dr. Robert Fuller Dearborn was born June 23, 1911 at Riverside, III. Following graduation from Proviso High School, he entered the University of Illinois, receiving a B. S. degree and his Doctor of Medicine in 1937. An internship at Madison Methodist Hospital qualified him for practice and in 1938 he became associated with a Freeport physician and practiced 18 months at Orangeville, III.

On April 1, 1941 he purchased his Byron office and began practice here. Enlisting in the Medical Corps of the U. S. Airforce in July, 1942, he was discharged with the rank of major in February, 1946.

Returning to Byron, he resumed practice and set, as his goal, new offices to replace the tiny, 100-year-old building which had been serving the community. This dream was realized in November, 1951 when a modern eight-room office was opened, offering the latest type of medical services and equipment to the community of Byron. With the ever present thought of expansion of services and activities, the building is designed to accommodate another physician.

Dr. Dearborn is married and has three children. He is an active member of service organizations in Byron, as well as Rockford, where he is a member of the executive staff of the Rockford Memorial Hospital, as well as the associated staffs of the other three hospitals.



# **Dixson's Department Store**

Mr. W. F. Dixson began operating Dixson's 5c to \$1 Store in Byron in 1936. He was located in the Embeck building, the place now occupied by the Bittner bakery.

He moved his store to the Jackson property in 1939. Then, on June 1, 1943, he bought the Nott property at the northwest corner of the main business block. The Barrick and Hunter clothing store had been located in this building for many years.


Expanding his business at this time, Mr. Dixson began serving the public under the firm name, Dixson's Dept. Store. He now operates a modern department store, selling many, many lines including wearing apparel for the family, furniture and floor coverings, Hotpoint appliances, Easy and Speed-Queen washers, notions, stationery, candy, etc.

#### Gamble Store Authorized Dealer

Morris W. Altenburg took over the authorized dealership as a Gamble Store in Byron on Oct. 1, 1941. He bought the business from Ambrose Stover.

Known as "The Friendly Store," the Gamble store offers the full line of Gamble merchandise, including hardware, home appliances, auto supplies and clothing.

Mr. Altenberg in recent years enlarged his store considerably to take care of his expanding business.

The Hi-Way Motor Service has a large fleet in service, including 17 tractors, 22 trailers and 4 straight trucks.





He now operates a general insurance business, handling all types of insurance.




Highest quality foods at lowest prices are featured by Johnson & Reber.






Louis Fasanella, standing by the barber chair in his shop. The chair is the very latest in barber shop equipment.



Dr. W. F. Michaux graduated from the Northwestern University Dental School in 1936 with the Bachelor of Science Degree








# **Wells Chevrolet Company**




Wilbur Whetsel putting the finishing touches on a pair of shoes in his shoe repair shop.

New home of The First National Bank of Byron


Probably the first thing a stranger looks for in a town is the bank. It is his assurance that there is a thriving business group, able to maintain a full agenda of transactions on a commercial basis. The presence of a bank in a community immediately sets the whole citizenry upon a business par with anyone else in the country.

That very need for financial security and backing prompted the formation of the first bank in Byron by Junius Rogers in 1873, just 28 years after the founding of Byron. Mr. A. B. Knowlton was cashier and partner in this bank, which was located on Second and Union Streets. Mr. Rogers was succeeded by Mr. Knowlton and he was followed by Mr. W. D. Brown of Geneva, who in turn was followed by R. D. Hollenbeck.

Meanwhile, J. C. Woodburn, in 1882, had organized a bank, a private institution which was continued many years under private management. In 1885 D. H. Campbell assumed the management and in 1892 S. B. Stuart, in partnership with other men, purchased the bank and it became known as the Byron Bank.

In 1921 it became the Byron State Bank when it took over the Farmers and Merchants Bank.

Wm. C. Bunn had withdrawn from the Byron Bank in 1891 and had established the Farmers and Merchants Bank, which in later years built the bank building which The First National Bank has just left. They continued in the new building until taken over by The Byron Bank and became the Byron State Bank until 1931.




Spacious interior of the new bank building.

The year 1931 was a time of distress in Byron for the bank closed and business was slowed perceptibly in the community. The need for a new bank became acute and finally on June 30, 1932 a charter was filed under the name of Rock River Community Bank with the organizers listed as Albert Johnson, Leo Piper, E. F. Reber, F. A. Nott, E. G. Stukenberg and D. L. Sherman. The roster of stockholders was impressive, indicating that the community spirit was at its highest point and was behind the venture whole-heartedly. Three hundred and four of the 915 citizens owned stock in this new bank.

A large celebration was organized to make festive the opening of the bank on July 7. Mayor Spoor opened the program and Mr. James W. Rogers, the new President, was introduced, as well as F. A. Nott, Vice-President, and other directors. Dr. Stewart Thomson acted as master of ceremonies and it was at this occasion that the support of Ruth Hanna Simms was announced. She pledged 10 per cent of the funds necessary for reorganization and her financial secretary was made president of the new institution which was capitalized at \$50,000. Total resources of the bank were then \$276,261.34. It was a small bank, but was one of the strongest in the Midwest in liquidity. The fact that the bank opened during an economic crisis and remained at the service of the community demonstrates the soundness of the organization.

In 1939 F. A. Nott was made President followed by O. F. Bakener in 1941, Leo Piper in 1943 and E. J. Auker in January of 1947.


