TAX LEVY ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE BYRON PUBLIC LIBRARY DISTRICT, OGLE COUNTY, ILLINOIS FOR THE FISCAL YEAR BEGINNING JULY 1, 2023, AND ENDING JUNE 30, 2024

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE BYRON PUBLIC LIBRARY DISTRICT, OGLE COUNTY, ILLINOIS:

Section 1: That pursuant to authority vested in it by law, including the Illinois Public Library District Act of 1991, the Board of Trustees of the BYRON PUBLIC LIBRARY DISTRICT, Ogle County, Illinois, does hereby find, declare, and ordain that the total amount of appropriations required to be assessed, levied and collected from the tax levy of the current fiscal year, in order to meet and defray all the necessary expenses and liabilities of said Public Library District, including the General Corporate Library Fund, the Illinois Municipal Retirement Fund, the Social Security/Medicare Fund, the Liability, Property, Damage, Risk and Insurance Fund, and the Audit Fund is ONE MILLION, TWO HUNDRED AND SIXTY THOUSAND DOLLARS (\$1,260,000).

Section 2: That the aforesaid sum, be and the same here is assessed and levied upon all of the taxable property in said public library district for the current fiscal year; and that said appropriated sum is to be collected from said tax levy for the current fiscal year, the total of which has been ascertained as aforesaid, and being as follows, to wit:

GENERAL CORPORATE LIBRARY FUND:

Amount to be Raised from Real Estate Taxes

\$1,140,000

The aforesaid amount of \$1,140,000 hereby is levied as the tax for general corporate purposes as provided by law in the Public Library District Act of 1991, 75 ILCS 16/1-1 et seq., or as otherwise provided by law.

ILLINOIS MUNICIPAL RETIREMENT FUND

Amount to be Raised from Real Estate Taxes

\$60,000

The aforesaid amount of \$60,000 hereby is levied as the special tax for Illinois Municipal Retirement Fund and contribution purposes and is in addition to all other library district taxes as provided by law in said Public Library District Act of 1991, or in 40 ILCS 5/7-171, et seq., or as otherwise provided by law.

SOCIAL SECURITY/MEDICARE FUND

Amount to be Raised from Real Estate Taxes

\$40,000

The aforesaid amount of \$40,000 hereby is levied as the special tax for Social Security/Medicare Fund and contribution purposes and is in addition to all other library district taxes as provided by law in said Public Library District Act of 1991, or in 40 ILCS 5/7-170, or as otherwise provided by law.

LIABILITY, PROPERTY, DAMAGE, RISK AND INSURANCE FUND

Amount to be Raised from Real Estate Taxes

\$10,000

The aforesaid amount of \$10,000 hereby is levied as the special tax for liability, property damage, compensation and risk insurance the expense purposes and is in addition to all other library district taxes as provided by law in said Public Library District Act of 1991, or in 745 ILCS 10/9-107, or as otherwise provided by law.

AUDIT FUND

Amount to be Raised from Real Estate Taxes

\$10,000

The aforesaid amount of \$10,000 hereby is levied as the special tax for audit expense purposes and is in addition to all other library district taxes as provided by law in said Public Library District Act of 1991, or in 50 ILCS 310/9, or as otherwise provided by law.

Section 3: That the total amount of ONE MILLION, TWO HUNDRED AND SIXTY THOUSAND DOLLARS (\$1,260,000) ascertained as aforesaid, be and the same hereby is assessed, levied and collected on all property within said Public Library District in order to meet and defray all the necessary expenses and liabilities of the said Public Library District as required by statute or voted by the people in accordance with the law.

Section 4: All unexpended balance of any item or items of the General Corporate Library Fund levy made by this Ordinance may be expended in making up any insufficiency or deficit in any item or items in the same General Corporate Library Fund levy made by this Ordinance. To the extent permitted by law, all unexpended balances of any fund levy made by this Ordinance may be expended in making up any insufficiency or deficit in any other fund levy made by this Ordinance.

<u>Section 5</u>: All unexpended balances of any item or items of the proceeds received annually from annual public library taxes not in excess of statutory limits may be accumulated in the Special Reserve Fund.

Section 6: That there is hereby certified to the County Clerk of Ogle County, Illinois, the several sums aforesaid, constituting said total amount; and the Secretary of the Byron Public Library District, Ogle County, Illinois, is hereby ordered and directed to file with the County Clerk of said County, on or before the time required by law, a certified copy of this Ordinance, and said County Clerk is hereby directed to cause the foregoing levy amounts to be assessed, extended and collected upon and against the taxable property within the territorial limits of the Byron Public Library District, Ogle County, Illinois, and in accordance with the laws and statutes of the State of Illinois.

Section 7: This Ordinance shall take effect and be in full force and effect

immediately on and after its approval, passage and posting as required by law.
